



Legislative Update

3/11/04

I'm sorry this one's taken so long to get out, but I've been hard at it visiting CBA chapters and any other group that will stand still and listen. Got to get the word out.

House Select Committee meeting - 3/4/04

Another good day for the home team! The first speaker was Mohammad Jenatian, from the Greater Charlotte Hospitality & Tourism Alliance. He pointed out that tourism in the Charlotte area alone was a 3 billion dollar a year industry. Statewide, the figure is 12 billion, and is responsible for keeping 200,000 people employed. He projected that being able to draw major motorcycle rallies to this state could have an impact of a billion dollars or more to our state economy. He was well spoken, and presented his information well.

Then came a presentation from Frank Folger, with the NC Dept. of Insurance. He basically told the committee what types of insurance are required in NC, and what types of optional coverage are available. I wasn't really sure what it had to do with anything. Filler, I guess.

Next up was Susan Valauri, with Nationwide Insurance. She came right out and said that the insurance company didn't have a stance on the helmet issue, so she brought someone else to speak!

That was Steve Oesch, with the Insurance

Institute for Highway Safety. While speaking to the press outside of the room prior to the meeting, he made it obvious that his opinion was a personal one. He passed out a very nice brochure, but the information in it was primarily NHTSA stuff that we've all seen a million times, and the Select Committee has already addressed. Rex Baker was quick to point that out to him. He asked if Oesch's organization had any original or new research, or if he was just going to stand there and spout NHTSA garbage. It was a beautiful thing to see. This guy even made a crack at me. He said that motorcycle race riders wear a full-face helmet, and it doesn't seem to bother them! The whole leather-side of the room groaned because they knew it was coming. Even a few suits chuckled. I thought I did a good job of not ventilating him though. I just pointed out that motorcycles in a race are typically all traveling in the same direction. I mentioned that the racers also do not have to worry about someone pulling out from a stop sign into their path, or some soccer-mom with a cell phone to her ear drifting in to their lane. (Why not plug a couple of other bills?) I told him that was a controlled environment, and unfortunately we don't have that luxury in the real

Womble stayed quiet until the end, but when he did speak he came so far from left field that

he may not be able to find his way home. He asked a few questions that seemed to be trying to demean the value of the jobs that motorcycle rallies would bring in to the state. Were these going to be full-time jobs or part-time jobs? No one seemed ready to get into the theory of trickle down economics, although Mohammad made a valiant attempt to put it in a nutshell. It was quite humorous. Every eye in the room rolled over that one.

As you can tell, these meetings are proving to be quite interesting. Our sponsors are doing a fantastic job, and the opposition has been showing poorly. If you haven't been able to attend one, you'll have your chance. The next one is Thursday the 18th, at 1:00. They're squeezing them closer together because of the two we missed due to bad weather.

I will be putting out another update soon on the status of our other issues, and a progress report on NC BikePAC. That is coming together better than I could have ever hoped it would, and it has definitely gotten their attention. Keep contacting those committee members! Yes that means youthat's why I said it!

SMART Committee Meeting March 20, 2004

The SMART Committee Meeting was held on March 20th in Monroe.

Jim opened up the meeting by everyone introducing themselves. Chapter represented were Buncombe by Roger Williams, Gayle Riley, Michelle Crane, and Tammy Blankenship. High Point by Darlene Kemsey. Brunswick by Don Paradise, Peggy and Jim Burns.

After this was done Jim asked the Chapters that were in attendance to tell a little about the work that was going on in their Chapters to promote Safety, Education and awareness. We quickly found out there were plenty of programs going on at the Chapter Level such as, two of our members Sterling Page and Jim Everhart attend the N.C. Motorcycle Safety Course to become certified instructors for N.C.

The possibility of setting up courses for CBA members to take from one of their own members that are certified instructor was discussed.

Buncombe has but together a program call "Two Wheel Trauma Seminar", featuring Slider Gilmore. He teaches EMS people how to deal with the conditions that are related to motorcycle accidents. Brunswick is working on a presentation dealing with group riding, which has a lot of possibility to introduce on a State level.

After discussing what is working at the Chapter level and what we see could be introduced Statewide it was decided that Committee would do best to but all available resources into one area and work that program until it became a reality.

The Committee overwhelmingly felt the

Motorcycle Awareness Program for High School Drivers Education students would be the best return for our efforts in promoting Motorcycle Safety. Darlene Kemsey told us of the presentation she, with the help of Sue Everhart, the MSF, and some young riders from the area had put together. Darlene agreed to let us film her next presentation with the help of her son-in-law Mike Allard, so we can have that video availably to all the Chapters. Hopefully this will encourage other members to get more involved in the program. Then we can set up a workshop to help those members learn how to make the presentation and how to get into the Drivers Ed Class to do the presentation.

This program is to be the main focus of the SMART Committee, until we spread the word that motorists can safely share the road with motorcycles.

Once again I feel there is nothing more important then keeping our brothers and sisters safe, healthy and alive. Our Committee is surely focused on that end.



At Burger King/Amoco (this is at a light) turn left onto SR1926 (Old Mount Olive) for 1/10 of a mile then go around concrete median and continue straight onto SR1222 (Bryan Boulevard). Follow signs to Busco Beach and CBA event. It is about 1.8 miles on this road to event site. WATCH THIS LAST 1.8 MILES. Sharp curve and one large bridge along the way.

From Route 70


From Charlotte Area

I-85 to I-40 towards Raleigh. At I-40 Exit 306 you will merge onto US 70 East. Then merge onto US117/US13S. Turn right onto SR1926 (Old Mount Olive). There is an Burger King/Amoco at this corner and a light. Go around concrete median and continue straight onto SR1222 (Bryan Blvd). Follow signs to Busco Beach and CBA Event. It is about 1.8 miles on this road to event site.

From Route 74 Monroe area

Travel east on US 74 to I-95. At I-95 Exit 58, bear right (east) onto US-13/117 for 46 miles. Turn onto SR1926 (Old Mount Olive) at the Burger King/Amoco. Go around concrete median and keep-straight onto SR1222 (Bryan Boulevard) Follow signs to Busco Beach and CBA event. It is about 1.8 miles on this road to event site.



Sam Nobles will handle getting local speakers to come out.


10. General Discussion:



Biker Lobbying 101: How to be a Biker Lobbyist

Why Lobby?

To make biker rights a reality, you must convince legislators that your position makes sense. Visiting a legislator is an essential tactic for furthering your campaign. Lobby visits can be made on the local, state, or national level, depending on the particular issue you are supporting. A lobby visit can be an incredibly rewarding experience, and all bikers should meet with their elected officials to discuss motorcyclists' rights issues.

Be Prepared

Know the issues. You can get information about legislation from CBA/ABATE of NC's

Legislative Coordinator Sam Nobles or from our website at www.cba-aba-tenc.org

Prepare Position Papers

Gather your facts and organize them into a one sided (two, only if absolutely necessary) page fact sheet. This will be the form that you will hand in to your representatives. Remember to be as concise as possible.

Make an Appointment If Possible

It is always a good idea to make an appointment to be sure that the appropriate people will be in the office. Remember, staffers and members have busy schedules. If you just show up, you will most likely only get to drop off your materials with a front-desk administrator who probably will not be able to discuss your issue. Before the Visit



you wear leather not only do the legislators you visit know you were there and why but so do all the other legislators who see you walking the halls. Bring extra copies of your fact sheets. Check the status of the bill that you are lobbying, and find out who has co-sponsored it. If possible, try and form a delegation by bringing friends who are also from your district. If

they are not from your district, you have no obligation to divulge this fact if you are not asked, but also do NOT lie if asked.

Visit the Bill's Sponsor

If you are lobbying for a particular piece of legislation, it is a good idea to call or visit the bill's sponsor before lobbying. They usually will be very eager to assist you in reaching the right members and will offer input on ways to present the issue.

The Opening of Your Visit

It is important to be as relaxed as possible during your visit. Expect to be a little nervous. If you have a delegation with you, choose a primary speaker based on familiarity with the issue and speaking skills. Introduce yourself to your representatives or their legislative aides (LAs). Let them know what bill or issue you are interested in, how you feel about the bill, and how it will affect you. Try to make this part as clear and concise as possible.

Answer Only Questions That You Know

Answer questions and offer your side of a stance. If you do not know an answer, tell your representative that you will get back to them. NEVER make up an answer. If you give out incorrect information, you will eliminate your credibility. Offering to get back to them also offers you a chance to re-familiarize them with your topic.

Don't Get Mean

After discussing the issue, if your representative or LA does not give you an answer that you want to hear politely thank them for their time, let them know that you still hold your position, urge them to reconsider, and politely leave. Do not get argumentative. Remember LAs and representatives are people, too, and may hold their stance more rigidly if you are unreasonable with them. No one likes working with someone who refuses to negotiate.

Be Flexible

If your representative opposes the bill that you want, see if you can come up with some common ground. Always offer to follow up on any new developments, and ALWAYS make sure that your fact sheet has all of your contact information.

Follow Up

After your visit, it is important that you follow up on any questions that you were unable to answer. Always send a note thanking your representative or LA for their time. If necessary, set up another appointment if you need to follow up on a new slant or topic. If your representative does what you told them to do, then be sure to thank them and let them know that you appreciate their efforts.

Benefits of the Visit

Your visit will not only help to persuade your representative, but it will also be an educational experience for you. During your visit, you will get an inside look at the political climate, and get insight on how to better promote your issue. Never be afraid to ask an LA a question about the actual mechanics behind government.

the downloaded file. When you have done so, click the "Save" button. The program will download the .exe file. (Note: This may take a few minutes. A status bar will appear to keep you apprised of the downloading progress.)

- 5. When the downloading has finished, go to your file manager and then go to the directory that you chose above. Double click on the .exe file and answer "Yes" to any Continue questions that appear.
- 6. At this point, you will be in the Set Up program. If you have other applications running, close them and then return to the Set Up page. Click the "Next" button.
- 7. Select "Accept" on the license agreement question.
- 8. Choose the directory that you created for the Destination Location, and click the "Next" button.
- 9. When the "Thank you" box appears, click the "OK" button. You are now ready to read PDF files. (Note: You may have to run the Acrobat Reader from your program manager once before it allows you to read the PDF files from web pages.)
- 10. Select the document's text link, and it will open in the Adobe Acrobat Reader.
- 11. If you wish to print the document, press the Acrobat Reader's "Print" button. (Do NOT use your web browser's "Print" command.) Your printed copy will have the same formatting as the original document.
