Legislative Update

April 2006

When the legislature is not in session, it often seems like our monthly updates are out-dated. However, each of the legislative issues we posted in our February update is still a vibrant issue to consider during discussions with your legislator, in his local office, prior to the start of the session in May.

Even though the NC Legislature is not officially open until May of this year, your government is hard at work preparing for the upcoming session. Special committee's have been busy this winter studying issues and developing legislative proposals for the upcoming session

This month's legislative update will focus on some of these committee meetings and topics/issues that your legislators are considering for the upcoming session. We have grouped them according to topic: Government and Ethics:

The House Select Committee on Ethics and Governmental Reform is preparing new legislation to address campaign contributions and lobbying reform proposals.

The House Select Committee on Ethics and Governmental Reform heard and discussed proposals to move toward greater public financing of judicial elections.

The House Select Committee on Ethics and Governmental Reform is developing a draft bill that would limit gifts to government officials to ten dollars.

The House Select Committee on Ethics considered proposals, based on the State Board of Election's inquiry into Jim Black's campaign contributions, to lower the reportable figure for contributions, to require that checks be filled out entirely, and to require PACs and 527s to forward checks within a set time period.

The House Select Committee on Eminent Domain Powers is working on new legislation, as citizens protest the appraised values of their properties, to ensure that property owners receive fair compensation for their properties when eminent domain is utilized.

The Environment:

The Environmental Review Commission is considering whether or not to implement new storm water management policies to help protect the environment in areas where the state is seeing tremendous growth and development.

The Joint Legislative Commission on Seafood and Aquaculture can be expected to put forth legislation this summer on requirements for storm water runoff, which may effect development plans in Eastern North Carolina.

Health:

The Subcommittee on the Cost of Health Care and Health Insurance discussed possible legislation that

aims to help local hospitals better aid stroke victims.

The Joint Legislative Oversight Committee on Mental Health, Developmental Disabilities and Substance Abuse Services examined North Carolina Medicaid benefits and allowances versus other states.

The House Select Subcommittee on Safety discussed ways in which the state might help prevent stroke cases and save lives by better preparing the state's emergency responses.

The House Subcommittee on Medicaid discussed and examined ways by which they might cut medicaid costs.

The subcommittee on Access reported, during a full meeting of the House Select Committee on Healthcare, that it would be putting forth new tort reform legislation during the short session. The House Select Committee on Health Care explored options, including incentives such as tuition payback programs, to make careers in psychiatric medical services, clinical services, and direct care services more attractive, in order to address statewide shortages in those fields.

The House Select Committee on Health Care heard proposals put forth by the state's University System to change the state's employee healthcare plan.

The House Select Committee on Health Care is studying the effects that tort reform might have on North Carolina's medical field.

The House Select Committee on Health Care heard resounding calls for healthcare reform, with some even calling for government issued "report cards" for doctors.

The House Select Committee on Health Care explored ways to make insurance more affordable for individuals and small business providers.

The North Carolina Study Commission of Aging will recommend a new program for the accreditation of direct care workers, NOVA (New Organizational Vision Award), which may be implemented statewide in 2007.

Economics, Finance, and Taxes:

The House Select Committee on Economic Development discussed the Bill Lee Act, possible revisions and economic Incentives.

The Revenue Laws Study Committee discussed proposals for further gas tax legislation as well as proposed legislation to close a number of corporate tax loopholes.

The Revenue Laws Committee discussed new proposals from the Institute for Emerging Issues as well as proposed bills on property taxes, personal income tax filing options and more.

Transportation and Infrastructure:

The Joint Legislative Transportation Oversight

Committee will recommend a plan for toll roads in Columbus and Brunswick Counties to the General Assembly.

The Joint Legislative Commission of Governmental Operations heard reports from the Port Authority on the need for a newly proposed port in Brunswick County, near South Port.

Immigration:

In a public meeting the national Census Bureau spoke of concerns over communication between state governments and the census, as well as concerns over the tracking of immigrants.

Summary: As you can see, your legislators will be busy this upcoming session promoting your issues during the short session. Some of these bills may meet the criterion for inclusion in the short session, while others may be discussed in committee and carried over into the 2007 session.

Your Chapter Legislative Goals should focus on:

- 1. Keeping your legislators informed of your opinions and/or concerns on the issues at hand.
- Keep your legislator informed regarding NC CBA/ABATE's official position on issues that the organization is focusing on.
- Developing a positive relationship with your Chapter Representatives and Senator.
- Organizing and preparing your Chapter-Constituent-Team for the trip to Raleigh during the upcoming legislative session.

through increasing knowledge, meeting new people,
making riding safer, and most of all, having lots of fun.
Here is just a sample of what we have coming up.

On April 3 and every first Monday of the month through June, we have our Hot Springs Planning Committee meetings. The first thing you will notice about this meeting is lots of really good food, a theme that continues in most everything we do. In addition, we sit down and work cooperatively together to iron out details and come up with ways to make what has become the premier motorcycle event in Western NC even better. All chapter members are welcome.

Also, there will be a banquet at a cost of \$25 per person, which we must have from you by the State Meeting if you want to attend.

On April 27 and every fourth Thursday of the month, we will be having a Public Relations/

The North Carolina Legislative Issue Teams

A New Perspective on Grassroots Activism

Introduction:

For years Legislative Directors for NC CBA/ABATE have been banging their head against a wall in efforts to work with legislators in Raleigh and Washington, DC. It is fair to say that we have approached the political representatives of the citizens of North Carolina prepared to secure or maintain our rights and freedoms. We have been well prepared for our activities. We have identified critical legislative and/or administrative issues, developed a process and procedure for interaction, and stepped up to the plate; in all our glory, armed with facts, righteousness, and the belief that we are entitled to a fair and just evaluation of the issue.

Although it is depressing to admit (we must be pragmatic) our efforts have not been successful. Even the limited successes we laud as victories are often abused or overlooked within a few months or years after implementation. Our recent "success" with the passage of the "Right of Way" act is an excellent example

Recently, a NC state administrative assistant was sentenced to 10 years in prison for the "white-collar-crime" of stealing money from Public Education coffers; during that same week a mother who was driving-drunk (transporting a baby in her car) (and, who subsequently fled the scene of the accident), was granted a suspended sentence and probation for killing a motorcyclist.

Even more depressing is the recent (unopposed) passage of a law restricting the use of All Terrain vehicles for children...The safety nannies have seen fit to legislatively override the decisions of responsible parents, regardless of our knowledge of our children's abilities, and/or the equipment we have determined is safe for them to operate. No one was there to stop them

In the fight for freedom we came prepared, we fought the battle on the high ground, we used the right ammunition, and we appeared to be gaining ground...why then, you might ask, are we not winning the war. I submit to you that there are two main reasons. First, we are approaching the issue in a disjointed manner, and; second, we are employing our battle strategy on the opponents turf.

Disjointed efforts

True to human nature, motorcyclists surround themselves with others of like-minds. We organize our recreational activities in domains that we are comfortable with, and associate with others who have similar interests and/or lifestyles.

Examples of this phenomenon are evident when we look at the types of motorcycle organizations that are in existence throughout the country... We have organizations for... off-road bikers, highway cruisers, sport bike enthusiasts, drag racing, and dirt track enthusiasts. I'm sure I've left out one or two specialized groups, but you have the idea.

Also true to human nature... groups within a domain of interest, identify differences between themselves and similar groups and highlight those differences

in a manner that allows them to feel "superior" in one way or another over the other group. This separation leads to dissension between the groups and divides these "similar" groups into opposing camps. Typical examples of this include the debate regarding helmet use, HD riders (vs.) everyone else, and moto-cross versus highway cruiser debates.

Often, we not only disagree, we publicly campaign against the issue of our sister group. This dissension increases the chances that more of our freedoms will be lost because the public and the politicians can see that (even among ourselves) we are divided.

A nation divided against itself cannot stand. If we are to be successful in the political arena we must set aside our differences for the greater good, harness our limited resources, and form a united front. An excellent example of this is the state of Ohio, where the AMA has joined forces with the two different ABATEs, the COC, and other collaborating organizations holding a vested interest in the passage of a ROW bill.

The Political Arena and the Culture of Politics-As-Usual

Most of us perceive of CBA/ABATE as a Grass Roots activist organization. Our political efforts, more often than not, have been aligned with our belief that altruism and taking the higher ground will provide us with justice. It might even be stated that, in some cases, our philosophical beliefs have prevented us from dirtying our hands in the "business" of politics.

The attitude that "politics is a dirty business" is not productive. Most politicians run for office because they desire to do good for the folks they represent. The job of disseminating the limited resources of the government is difficult and has few rewards. Our legislators are dedicated public servants who are doing all they can to get a fair share of the limited resources of government assigned to their home constituencies.

We aren't at war with the politicians. If anything, when legislation of interest is before a legislative body, our grassroots lobbyists are "in competition" with an exceptionally well funded organization of professional lobbyists, supported by an administrative and research staff, equipped with modern tools of communication and vast resources that far exceed the fiscal abilities of our grassroots activist organization. A typical example is the American Medical Association or Traumatic Brain Injury Association, and the professional lobbyists they hire to oppose our helmet amendment.

The Solution...Commitment to Change, and Establishment of Inter-organizational Collaboration:

We must change our attitude about the political process, and those involved in politics. No longer can we perceive of ourselves as "Legislative Warriors" preparing for hand-to-hand battle in our crusade for freedom. We must begin to look at ourselves as an important cog in the intricate mechanism of government, and act in a professional manner. As our organization's lobbyists we perform an important role in a specific environment with an established decorum and tra-

dition. We must learn to respect and work in the legislative culture, in a manner that respects the time-honored traditions of our legislature.

In that same light, we can no longer be perceived as the "step children" of the political process. In order to successfully compete for resources against other special interest groups we must re-think our positions. We must organize ourselves in a manner that presents a united professional front.

Because we have limited fiscal resources we must reorganize and refit our networks in a manner that allows us to use the vast dedication and talent of our membership. We must drop our separatist postures and take up the sword of collaboration among motorcycling organizations.

The NC Legislative Working Party

To this end the NC CBA/ABATE has created the North Carolina Legislative Working Party. The LWP is a committee of rights activists formed by the legislative Director of the CBA/ABATE. The structure of the LWP includes an executive panel of representatives from all stakeholder Motorcycle Rights Organizations in North Carolina, and several "Issue-Specific- Legislative-Teams".

Representation of inter-organizational members on the executive panel of the LWP, and collaboration among stakeholder MROs will allow the motorcy-clists of NC to speak as a United Front. The development of Legislative Issue Teams will provide the support we need to effectively compete with other organizations across a wide variety of critical issues, and present a professional image to our legislators.

Legislative Issue Teams

The North Carolina Legislative Working Party recently began the process of developing several Legislative-Issue-Teams that will focus on specific state and national issues of interest to the MC community. Our goal for these small groups of dedicated individuals, is for them to create, develop and maintain a resource base, become experts in a specific issue (i.e., Intelligent Transportation System/Helmet Amendment/ Anti-discrimination, etc), and serve as a support network for our lobbying activities in Raleigh and Washington, DC.

Tasks these teams perform include; topic specific research, data collection and analysis, preparation of issue summary/briefing packets for lobbyists, preparation of topic-lists for citizen testimonials before legislative committees, and informational packets for legislators

The Concept and the Curriculum for Preparing Legislative Issue Teams:

The overall goal of the NC Legislative Working Party is to create a grass roots political organization within the motorcycling community of NC to effectively disperse legislative information and organize responses to proposed legislation.

We wanted the NC Legislative Working Party to mimic the activities of professional lobbying organizations, and perform the activities of successful MROs in other states.

The North Carolina Legislative Issue Teams (cont.)

We began with what we were familiar with, our NC CBA ABATE Legislative Coordinator network of communication. Within NC, each chapter of CBA/ABATE has a legislative coordinator, who's responsibility is to educate the membership and organize local political activities. Using this network as a model, we began to create a statewide communication infrastructure that included members of all the Motorcycle Organizations in North Carolina.

Next we identified the issues that were important in North Carolina and at the federal level. The we sent out word that we were accepting applications for individuals interested in participating in the training sessions. We called the training a Legislative Retreat.

We began our training session using the following issues...

- Helmet Amendment
- Anti-Gang Legislation

- Construction Signage
- MC Awareness Funding
- Anti-discrimination
- MC Specialty Plates
- Left turn on Red Light Bill
- Retread-Tire Serial Numbers
- EPA Regulations
- Increase ROW Violation Penalties
- Cell Phone Usage
- Patriot Act
- Eminent Domain
- Health Care
- Right to Repair Legislation
- Motorcycle Safety Education
- The Patriot Act
- HIPPA (Health Insurance)

We developed portfolios related to the topics of interest and provided guidelines for team reports on the issues. We then set our teams to work on ran-

domly designated issues. The results were astounding. Participant evaluation of the program indicates that the educational model was effective, and that participants valued the knowledge they received regarding all of the issues.

Conclusions:

As a result of our Legislative Retreats we have already formed six issue-specific-teams to support the activities of our lobbying efforts in Raleigh. We recognize that we have much to learn, and a lot of hard work ahead of us. However, as a result of our enlightened attitude toward our activities at the state capitol, and with the support of our Legislative Issue Teams, we feel confident that we will enter the legislative arena in Raleigh better able to compete with other special-interest and lobbying groups on a level playing field. The proof will be in our legislative successes. Watch for North Carolina in the MRO news...


